## Sample Language to Include The Lakeland Foundation in a Will or Bequest

Private support to Lakeland Community College is accepted, invested, and disbursed by The Lakeland Foundation, a 501(c)(3) foundation in the State of Ohio with Federal Tax ID #34-1369714.

The legal name for all gifts through wills, trusts or beneficiary forms is The Lakeland Foundation.

## Sample Bequest Language

"I bequeath to The Lakeland Foundation (Tax ID #34-1369714), a nonprofit organization located in Kirtland, Ohio:

- the sum of \_\_\_\_\_dollars; or
- an amount equal to \_\_\_\_\_ percent of the net value of my estate; or
- all the rest, residue, and remainder of my estate."

"It is my request that this gift be used for the benefit of [specify fund, program, department, or other purpose] at Lakeland Community College, as directed in my most recent statement of intent\* with The Lakeland Foundation."

\*[The statement of intent is what you have communicated to us through either a <u>Confidential</u> <u>Intent of Future Philanthropy form</u>, endowment agreement, or other signed document. This enables you to easily revise your intentions without modifying your will.]

The language above is intended as an example only. Please consult with your legal and/or tax adviser before drafting any legal instrument.

## **Supporting a Fund or Named Endowment**

You may designate your bequest to support any of The Lakeland Foundation's existing endowments (e.g. an endowed scholarship or program fund) or to establish a new or named endowment fund. In order to do so, <u>please contact us before finalizing your bequest to discuss necessary wording and minimum giving levels to ensure that The Lakeland Foundation can fulfill your wishes.</u>

Endowments may be established that name the donor or an honoree, and with or without the purpose included in the name - for example:

Chris and Pat Smith Endowed Scholarship Fund The Smith Family Endowed Scholarship Fund Chris Smith, Ph.D. Memorial Scholarship Fund
