

Physical Therapist Assistant (9365)

Associate of Applied Science Degree

Physical therapist assistants (PTAs) provide physical therapist services under the direction and supervision of a physical therapist. PTAs implement components of patient care, obtain data related to the treatments provided, and collaborate with the physical therapist. PTAs assist the physical therapist in the treatment of individuals of all ages, from newborns to people at the end of life. Many patients have injuries, disabilities, or other health conditions that need treatment; however, PTAs also care for people who simply want to become healthier and to prevent future problems.

PTAs work in a variety of settings which include hospitals, nursing homes, school systems, outpatient centers, private practices of physical therapists, and inpatient rehabilitation facilities.

Lakeland's Physical Therapist Assistant degree program prepares students to be competent entry-level PTAs. Upon satisfactory completion of the program requirements, graduates are eligible to take the National Physical Therapy Licensure Examination (NPTE) for PTAs, which is necessary for state licensure. Students convicted of any felony or misdemeanor may be prohibited from applying for the NPTE.

Students must be admitted to the Physical Therapist Assistant program to enroll in PTAS courses. The Physical Therapist Assistant program consists of five semesters, the first of which consists of prerequisites which students must complete before being admitted into the program. Other general education courses may be taken prior to admission to the program.

All students enrolled in a nursing or allied health program/certificate must complete a criminal background check. In accordance with clinical site requirements, students with a criminal record may be ineligible to participate in a clinical education experience course.

Delays, for any reason, in obtaining background results may cause an interruption in the clinical rotation sequence or inability to complete program requirements. Additional background screening may be required by individual facilities.

Drug testing may be requested in accordance with clinical affiliation requirements and/or for patient/ student health and safety.

A minimum GPA of 2.0 and a "C" grade or higher is required in all physical therapist assistant and general education courses as listed in the curriculum guide for the Associate of Applied Science (AAS) degree in Physical Therapist Assisting. Satisfactory/Unsatisfactory grades may not be used to fulfill health program requirements.

Admission Procedures

Students must meet specific admission requirements for this program. Listed below are requirements for admission to the Physical Therapist Assistant program:

Option 1: High School Option

This option is for current high school seniors or high school graduates who apply to the program within two years of high school graduation.

- Complete college application(s).
- Composite score of 21 or higher on the American College Test (ACT) or combined score of 940 on the Scholastic Aptitude Test (SAT).
- Place into MATH 1330 Statistics for the Health Sciences or higher or pass MATH 0850 Beginning Algebra
- Complete high school algebra, chemistry, and biology with a "C" grade or higher.
- An overall high school GPA of 2.5 on a 4.0 scale or equivalent.
- Meet with a counselor to review program prerequisites and requirements.
- Complete a minimum of 20 hours of observation in a physical therapy department under the supervision of a licensed PT or PTA. The hours must be in a minimum of two different physical therapy settings, ten hours at each site. It is the applicant's responsibility to

contact a physical therapy department to arrange for this observation. It is advisable to begin your observation experiences as soon as possible to ensure this career path is the most appropriate for you.

Students must also complete the following courses with a "C" grade or higher and an overall GPA of 2.0 or higher. Applicants must have completed BIOL 2210 Anatomy and Physiology I and HLTH 1215 Medical Terminology for Health Professions with a cumulative GPA of 2.5 or higher.

- BIOL 2210 Anatomy and Physiology I
- ENGL 1110 English Composition I (A) or ENGL 1111 English Composition I (B)
- FYEX 1000 First Year Experience
- HLTH 1215 Medical Terminology for Health Professions
- HLTH 1500 Ethics and Legal Issues for Health Professionals
- PSYC 1500 Introduction to Psychology

Upon successful completion of the above criteria, the applicant will be admitted into the program.

All interested students must meet with the PTA program director before submitting the application. Please call 440.525.7470 to schedule the meeting.

Option 2: College Option

This option is for students who do not qualify for admission under Option 1.

- Complete college application(s).
- Submit high school transcript as well as any college transcript(s).
- Successful passing score on the required program pre-admission test as indicated under Option 1, or a score of 62 or higher on the Test of Essential Academic Skills (TEAS).
- Meet with a counselor to review program prerequisites and requirements.
- Complete a minimum of 20 hours of observation in a physical therapy department under the supervision of a licensed PT or PTA. The hours must be in a minimum of two different physical therapy settings, ten hours at each site. It is the applicant's responsibility to contact a physical therapy department to arrange for this observation. It is advisable to begin your observation experiences as soon as possible to ensure this career path is the most appropriate for you.

Students must also complete the following courses with a "C" grade or higher and an overall GPA of 2.0 or higher. Applicants must have completed BIOL 2210 Anatomy and Physiology I and HLTH 1215 Medical Terminology for Health Professions with a cumulative GPA of 2.5 or higher.

- BIOL 2210 Anatomy and Physiology I
- ENGL 1110 English Composition I (A) or ENGL 1111 English Composition I (B)
- FYEX 1000 First Year Experience
- HLTH 1215 Medical Terminology for Health Professions
- HLTH 1500 Ethics and Legal Issues for Health Professionals
- PSYC 1500 Introduction to Psychology

NOTE: Students must meet one of these requirements to take BIOL 2210 Anatomy and Physiology I with a "C" or higher:

- High school biology within last five years and high school chemistry.
- High school biology within last five years and CHEM 1100 Elementary Chemistry
- BIOL 1200 Fundamentals of Biology for the Health Technologies












Students are required to take the Math Placement Test and be placed into MATH 1330 Statistics for the Health Sciences or higher or complete MATH 0850 Beginning Algebra with a "C" grade or higher.

All interested students must meet with the PTA program director before submitting the application. Please call 440.525.7470 to schedule the meeting.

Option 3: Advanced Education Option


Students pursuing this option must have an Associate of Applied Science degree in Nursing or Allied Health, an Associate of Science degree, or a bachelor's degree to be waived from the preadmission testing. All other Option 2 requirements apply.
